Conditions of Service

- 1. All service fees must be paid and received in full, including the clearance of all cheques, prior to collections of any semen
- 2. Service fees are non-refundable.
- 3. One service certificate will be issued per service fee paid. If two mares are bred with one insemination dose and both parties are pregnant, a second service fee is payable.
- 4. Collection of and transportation costs for the semen are payable by the mare owner.
- 5. In the case that the stallion should be injured to prevent breeding, die, or be sold, the mare owner is entitled to a full refund (excluding costs already incurred)
- 6. Mare owners are advised that a live foal guarantee does not guarantee that a live foal will be born to the mare being bred. The term entitles the mare owner to a return breeding for the same mare to the same stallion, in a subsequent breeding season. This applies in the case that the mare should a) fail to conceive, b) abort the foetus, or c) the foal dies within one month of birth. A veterinary certificate must be supplied as documentation of this situation.
- 7. Should the mare owner fail to have a veterinarian examine the pregnancy for twins or abortions at or before eighteen (18) days after insemination, and between forty (40) and sixty (60) days after conception, the live foal guarantee will be void. Mallyon Hills Warmblood Stud will not honour Live Foal Guarantee when the mare owner has neglected to undertake appropriate examinations.
- 8. The stud must be notified within 7 days of the results of the pregnancy examination as noted above.
- 9. The stud is not obliged to honour the live foal guarantee when the mare loses a pregnancy due to poor health caused from the owner's neglect. Appropriate feed, water and care should be maintained to the pregnant mare at all times.
- 10. Should a replacement mare be required to exercise the live foal guarantee, then a \$250 rebreeding fee will be charged.
- 11. Should a mare fail to conceive, or the mare owner changes their mind, the mare owner has no claim for a refund. Replacement mares may be used as per the above clause.
- 12. The breeding season shall commence on the 1st September and close on the 1st March. Mares must be bred within this period.
- 13. The stud exercises the right to refuse any mare for breeding for whatever reasons.
- 14. All accounts must be paid in full before a service certificate will be issued.
- 15. Whilst we shall always try to be helpful, 48hrs notice prior to semen collection is appreciated.
